RE: Important Warning

Please be aware that certain individuals or entities may falsely present themselves as representatives of Global Trade CIF Ltd or our brand Finansero, through telephone calls or emails. The individuals may pose as Finansero representatives to solicit investors to send funds or take other actions related to their trading accounts.

We urge you to remain vigilant and be cautious of any unsolicited communication claiming to be from our company, and to refrain from sending money to anyone claiming to represent it. Any transfer of funds to your Finansero self-trading account should be done only through the official methods provided by the company.

It has come to our attention that an entity operating under the name “Brain Trade” has been engaging in activities that may negatively impact our clients’ experience on our trading platform, including implying or stating that they are associated with our company and Finansero. We are not aware of the practices or services of such entity and whether it has provided unauthorized services. The company would like to inform its clients and the general public and stress that it is not related to this entity or any other third-party providing training services or investment advice.

Further to the above, it has also come to our attention that certain individuals or entities may be contacting clients while referencing cryptocurrency-related transactions or requesting payments in crypto assets. Please note that our company does not accept cryptocurrency payments, nor does it engage in any activity involving the solicitation of funds through crypto assets. Clients are strongly advised to exercise caution and to disregard any such requests.

Please be aware that any services, recommendations or advice provided by any third party are not affiliated with or endorsed by our company. We urge you to be cautious and avoid following any trading guidance coming from this entity or any other similar entity while using our platform. Our company remains committed to providing you with a safe, transparent, and reliable trading experience, and we want to ensure that your decisions are based on sound, independent judgment.

We recommend that you only follow official channels for trading guidance and always ensure that any decisions you make are based on your own research or from qualified professionals you trust.

The company reminds its clients that it will never contact them to solicit them for deposits, fees or funds in general, nor to take any investment actions on their trading accounts unless the client personally instructs the company.
